

## **Official Contest Rules**

The Go Fish! Campaign promotion is in conjunction with the Rainbow Hospice and Palliative Care Promise of Park Ridge 2010 Public Art Project.

### **1. How to Enter the Contest**

One entry per person. Multiple entries will not be accepted and will not increase your chance of winning. Valid entries must be received during the effective contest dates from July 25<sup>th</sup>, 2010 through September 30<sup>th</sup>, 2010. Late entries will not be accepted. In order to enter, participants may pick up a Go Fish! Fishing Log entry form from Rainbow Hospice and Palliative Care, 444 N. Northwest Hwy., Suite 145, Park Ridge, IL, or participating fish locations. Entry forms are also available online at [www.RainbowHospice.org/gofish](http://www.RainbowHospice.org/gofish). To be accepted, forms must be completely filled out with the names of the fish and valid participant contact information.

### **2. Eligibility**

Void where prohibited. All entrants must be of legal age, eighteen (18) or older. Participants under the age of eighteen may have an entry submitted in their name with the consent and signature of a parent or legal guardian. Open to US residents only, employees in the Rainbow Hospice Development Department (and their immediate family and household) are not eligible to participate.

### **3. Prizes**

Up to eleven (11) total winners will be selected from all valid entries. Prizes consist of ten (10), \$50 Park Ridge Chamber of Commerce Gift Certificates and one (1), \$250 cash Grand Prize. Prizes are not refundable and non-cash prizes are not redeemable for cash. Prizes are not transferable. Winners are responsible for all applicable taxes. Maximum one (1) prize per person. Total prize value collective to all prizes approximately \$750. All prizes subject to change based on availability.

Park Ridge Gift Certificates are valid only at participating businesses in Park Ridge. Gift certificates are accepted by Chamber members and certain non chamber businesses. A list of participating businesses will be provided to prize winners and is also available at the Park Ridge Chamber of Commerce.

### **4. Sponsor**

### **5. Choosing and Contacting Winners**

Odds of winning are determined by the number of valid entries.

Winners will be notified by e-mail and/or phone within two (2) calendar days of the drawing. After this notification, winners have three (3) business days to contact Rainbow Hospice and Palliative Care to

claim their prize. If a chosen winner does not contact Rainbow Hospice in the required timeframe, is found to be ineligible, violates contest rules or if the prize is refused or found to be undeliverable, an alternate prize winner may be chosen from the pool of additional valid entries.
